## CONSERVATION

According to Jim Pratt, our Chairman on Conservation, Tom Stienstra's Outdoors column in the San Francisco Examiner recently highlighted some of the latest skulduggery of the State Department of Fish and Game.

Starting the first of April, a new state law kicks into effect prohibiting gillnets along the entire Bay Area coast. The law is designed to stop the illegal kills of sea birds and marine mammals in the nets. The law also protects inshore halibut, rockfish and the lingcod fisheries that had just about been cleaned out by dragnet boats.

It may sound like the type of legislation that DFG would support but it seems the DFG has quietly issued seven "experimental permits" to allow commercial trawlers to drag giant nets along the Bay Area coast, anyway. These nets kill everything in their path including salmon and striped bass. These nets are the ultimate vacuum cleaner. The Russians use the same technology to clean out fisheries all over the world.

How can Fish and Game issue these permits when their job is to be the guardian of our fish resources? Try writing to the Director of Fish and Game at 1416 9th Street, Sacramento, CA 95814.

FRIDAY, FEBRUARY THE 13TH

I began writing this on Friday, February the 13th in the early evening. As I looked out the window I could see a large, bright moon rising over a calm sea between the waving fronds of many palm trees. It was a very tropical evening in a very tropical setting, Ambergris Cay, Belize.

For myself and friend, Mike Ripley, the day was just what we might have expected it to be for a Friday, the 13th, even though neither of us are particularly superstitious. With our very knowledgeable guide, Erlindo, we fished several bonefish flats or "bonefish" as Erlindo calls them. We were on the first flat by 9 A.M.. The bonefish were there, but because of the ultra calm water we were soon to find out they were even more spooky than normal.

I was first up on the boat's front bow. It did not take long for Erlindo's eagle eye to spot the tail of a feeding fish as it rooted for food in the soft, sandy bottom of the shallow bay. I stood tensely but ready as Erlindo poled the boat into a better casting position. Now, the fish was working towards us.

"Strip. Strip. Strip," whispered Erlindo. After a few strips, the fish zeroed in on my fly. There was a large wake as it sped purposely towards the seeming mouthful of food. There it was, the tail tipped up. I struck, but not too hard, remembering bonefish have fairly tender mouths. I had him! It took off like that old saying "greased lightning." The few loose coils of fly line in my hand were quickly gone ...that is except for the last loop which, unknown to me, was wrapped around my index finger. There was a sudden pull, then nothing. My carelessness had cost me the fish.

"How big?", I managed to ask. "Between four and a half or five pounds" answered Erlindo, "that was a very nice bonefish." "Well, Parker, looks like you goofed again," Mike kidded as we changed places in the boat. Now it was his turn.

Erlindo, alert as always, carefully poled the boat. "Here they come," he said excitedly. "Three o'clock, a big school." "Where?" "Where?" Mike yelled. "I can't see 'em. There's too much glare on the water. Erlindo quietly answered "Now they are at 11 o'clock and moving towards us. See them? See them, now?"

Mike was almost shouting. "OK, I've got 'em." The school was cruising, feeding or grazing as they moved. They were within casting range. Mike's cast shot forward. With a slight "plop, the No. 6 Olive Shrimp fly landed just a few feet in front of the oncoming school. There was a loud boil on the surface as fish scattered in every direction. "Spooked" Mike said in a deject tone of voice.

"It was a good cast," Erlindo soothed, "but one never knows about the bonefish. Sometimes they seem to scare a lot easier than at other times."

That is how the rest of our day went. We hooked, lost, spooked and did just about everything else but land a fish. I was beginning to be a believer in Friday the 13th, and this particular one was our last day of fishing in Belize. We did not, however, let the experience of the day mar the memory of the great week we had just had. We chalked it off as part of our learning experience.

This week had been the first time either of us had ever fished for bonefish. The week had certainly had its ups and downs, but we were more than satisfied and had enjoyed both the good with the bad. We both felt fortunate just to be there. After a lot of research, Mike had chosen the El Piscador Lodge on Ambergris Cay, Belize, which is located, a short 20 minute flight by small plane from the airport in Belize City, Belize.

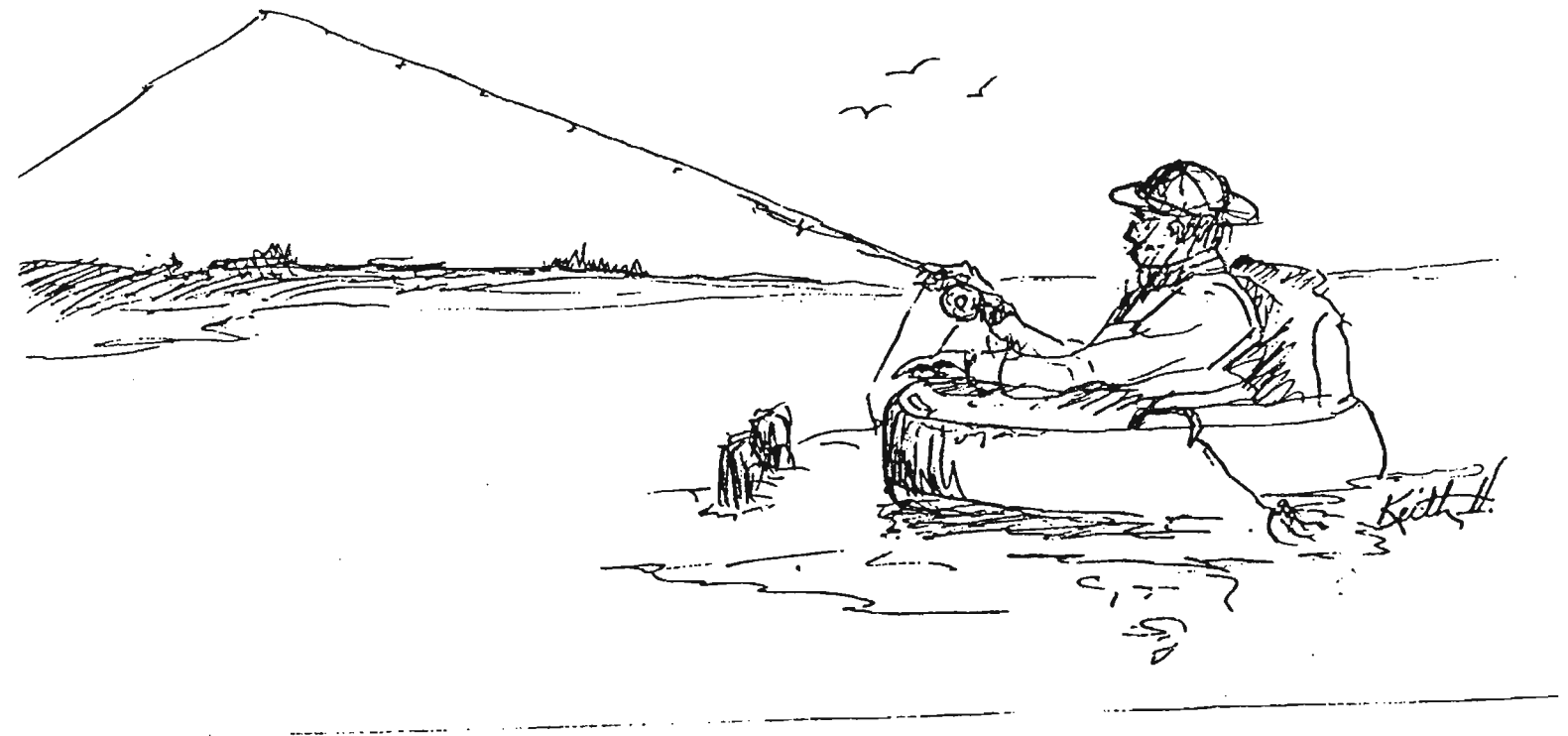
"Belize, where the heck is Belize?" you may be asking yourself. That's the same question I asked, when several months before our trip, Mike had called and asked I would like to go there and fish for bonefish. He had explained that Belize used to be called British Honduras and that it is located just a round the corner from Mexico's Yucatan peninsula. I finally got the picture.

Mike made all the arrangements. I flew from Los Angeles directly to Belize on a TACA Airlines 767 jumbo jet. Mike, an airline pilot with more than 20,000 hours flying time as a captain for TACA. He feels it is one of the finest airlines in the world. He may be right. I know I was impressed, The people at the airlines were waiting for me. "Captain Ripley has arranged everything," the smiling lady at the ticket



counter told me. The plane's captain, Victor Alfaro, even asked me to ride in the cockpit. That was some flight. Anyway, we did have a great week in Belize. I would strongly urge anyone interested in fishing for bonefish to go there. The Kruegers, owners of the El Pescador, are wonderful hosts and the lodge is very comfortable. They have their own staff of very knowledgeable guides, who are fly fisherman themselves.

Mike and I are planning a return trip in November. Believe me, I can hardly wait.



## MEMBERSHIP RENEWAL CHANGE

The club's current system of membership renewal on a member's anniversary date results in funds being received in an erratic and unpredictable manner throughout the year. And, since membership renewal is uncertain, so is the club's income.

Therefore, to help determine what funds will be available to plan the year's activities, the Board has decided to change future memberships to be renewed on a calendar year basis in January of each year. This will become effective in January 1989.

This means renewals already made in 1988, those yet to be made later this year, and all new memberships will need to be renewed in Jan. 1989. Renewals after that will always occur in January of the following year.

Here is how it will work:

Members who joined or renewed in Jan., Feb. or March 1988-  
renew in Jan. 1989

Members who join or renew between April and Dec. 1988-  
pay prorated dues equal to 1/10 of the annual rate  
for each month left in 1988.

For example:

Renewal/New Individual membership in May 1988  
May is the 5th month. With 7 months remaining  
the dues will be 7/10 of \$20 for a total of \$14.

Also starting in 1989, new members joining in the 1st quarter will pay the full yearly rate. Those joining after the 1st quarter will be prorated as described above.
